 Education Rules 2010.
- 3. The School shall admit in class I, to the extent of 25% of the strength of that class, children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion. Provided, further that in case of pre primary classes also, this norm shall be followed.
- For the children referred to in paragraph 3, the School shall be reimbursed as per Section 12(2) of the Act. To receive such reimbursements school shall provide a separate bank account.

 - The teacher performs its duties specified under Section 24(1) of the Act and (vii)
 - The teachers shall not engage themselves for private teaching activities. (viii)
- The School shall follow the syllabus on the basis of curriculum laid down by 8. appropriate authority.
- The School shall enroll students proportionate to the facilities available in the school as 9. prescribed in the Section 19 of the Act.
