Sir,

As you are aware that the National Commission for Protection of Child Rights (NCPCR) under Section 13 (1) (j) of CPCR Act, 2005 inquires into complaints and takes *suo-moto* cognizance in relation to deprivation and violation of child rights.

- 2. The Commission received a representation from President, Organisation of Parent Association' Forum, Odisha enclosing a copy of Notice issued under your signature providing the list of English Medium School which has been granted NOC. As mentioned in the representation, the State has 5,779 schools out of which only 291 schools have the NOC. Therefore, the Commission is concerned about the future of students studying in schools who have not obtained NOC.
- 3. In this regard, you are requested to take appropriate action on priority basis and streamline the process of issuing NOC. Also, furnish an action taken report within 30 days to this Commission.
